- I will take care when using the computer equipment and will not change the computer settings.
- I will not use the school computers to be mean, rude or unkind about other people.

I understand that:

- If I use the computer or internet in a way that I shouldn't I may not be able to use these in the future.
- I may be legally liable for misuse of the computer and the school may take appropriate action if I have incorrectly used the technology.
- Material on my device can be viewed by the school.
